

THE MISSION

The mission of the El Paso Symphony Foundation is to develop, promote, administer and maintain a significant long-term endowment and special projects fund for the exclusive benefit of the El Paso Symphony Orchestra Association, in order to preserve and improve the high quality of the orchestra and ensure its strong presence in El Paso for the future.

THE ORGANIZATION

The Foundation is a separate legal entity that provides a formal structure for giving and is a vehicle for assuring the financial future of the El Paso Symphony Orchestra.

THE FUNDS OF THE FOUNDATION

General Endowment Funds are comprised of direct contributions and funds from planned giving. Only the income is used for current operating needs of the Association. Principal is reinvested to enhance future earnings.

The El Paso Symphony Foundation has established these funds within the Foundation to meet the long-term needs of the Symphony and to create a variety of giving opportunities of interest to donors.

- a) Foundation Unrestricted Fund. The Foundation Legacy Fund is an unrestricted fund established to support annual operating needs and priorities of the El Paso Symphony Orchestra. Donors may establish a *Named Fund* for unrestricted purposes with a minimum contribution of \$10,000.
- b) Musician Development Fund. The Fund was created to ensure continual resources to maintain sufficient resources for musician salaries, recruitment and training of new musicians. Distributions will be made on an annual basis to support salaries, recruitment, and other expenses related to musicians. Donors may create a named fund in the Musician Development Fund with a minimum contribution of \$20,000.
- c) Young Artists Fund. The Young Artists Fund was created to support the operating and capital needs of the El Paso Youth Orchestra. Donors may create a named fund in the Young Artists Fund with a minimum contribution of \$20,000.
- d) Education & Outreach Fund. The Education & Outreach Fund has been established to support the all El Paso Symphony education and outreach efforts such as Brass in Class, Strings in Schools, Young People's Concerts, Golden Notes, Symphony Seniors, Kids Klassics, and Angel Tickets. It will also facilitate the development of new programs for special populations. Donors may create a named fund in the Education & Outreach Fund with a minimum contribution of \$20,000.
- e) Special Named Fund. The fund can help support the development of commissioned pieces, special multi-media projects or consist of direct contributions and funds named for a donor, family member or friend. Donors may create a named fund in the Special Projects Fund with a minimum contribution of \$10,000.
